Ms. Pyle is the Project Director of the Risk Management Group at SCS Tracer Environmental and a Vice President of SCS Engineers, Inc. Ms. Pyle has worked with industry groups to develop standardized Process Safety Management Programs (PSM) for industry members to ensure compliance with OSHA's 1910.119 regulation (Cal-OSHA Title 8, §5189). In addition to developing PSM programs for industry, Ms. Pyle has also been involved in auditing facility's PSM programs. Her vast experience in developing programs for numerous facilities brings new ideas and innovative methods for facility with respect to managing and implementing their individual PSM programs.

Ms. Pyle's experience includes all aspects of preparing a CalARP or PSM program. This includes participating in Hazard and Operability Studies as the team leader, quality control, or recorder, preparing qualitative risk assessments, and conducting off-site consequence analyses.

Ms. Pyle is also involved in the preparation of Operations Manuals for facilities transferring bulk oil. This includes updating the Venoco, Inc. Operations Manual for their Marine Terminal facility to incorporate a new vapor control system. In addition to the Facility Operations Manual, SCS Tracer Environmental developed the Training Manual and Vapor System Operations Manual.
